In simple terms: This is a 12 month agreement, each month you will pay your membership dues, which covers the cost of one member massage. If you are unable to visit The Massage Center, you will still be charged the membership dues, and any unused member massages shall rollover. Upon cancellation of the membership, unused massages shall expire. Your membership dues of \$\_\_\_\_\_ will be due on \_\_\_\_\_ and due on the same day each month hereafter until your membership expires or is terminated in accordance with this agreement. Your membership is auto-renewable. Following the initial term your membership will automatically continue on a month-to-month basis at \_\_\_\_\_ per month until your membership is cancelled. You may cancel your membership during the initial term only in the event that you permanently relocate your residence more than 25 miles away from any of The Massage Center locations or a physician certifies that you are unable to receive massage therapy. All membership cancellations require 30 days written notice and are effective 30 days after the date received. Payments are due prior to the effective date will be charged as scheduled. You have the entire initial and renewed term of the membership agreement to use all membership massages. You may continue to redeem your membership massages as long as your membership is in effect and is paid current. Upon termination or cancellation of your membership, all unredeemed membership massages will expire.

You may cancel a massage appointment with no charge any time before the close of business on the business day preceding your appointment. Same day cancellations will be charged 50% of the scheduled service price. If you do not call to cancel or do not show up for your scheduled appointment, you will be charged full price for the scheduled service.

By signing below, I authorize The Massage Center to charge the account I have specified. Monthly dues and / or renewal fees will be withdrawn on or after the same day of each month. I understand The Massage Center may continue to charge my account or cancel my membership in accordance with the terms and conditions of this agreement. Additionally, I authorize The Massage Center to charge my credit card on file in lieu of presenting it for any services received, at my request. The Massage Center agrees to sell, and you agree to purchase the membership, goods, and services described herein. You agree to pay The Massage Center for the membership, goods and services according to the payment schedule above.
